It is vitally important that the governing body of every pastoral charge and presbytery cast a vote on all applicable remits. An absolute majority is needed for the remits to pass, not just a majority of those that vote. If passed by an absolute majority, each remit will go to the 43rd General Council 2018 for approval. **If a governing body of a pastoral charge or presbytery does not vote, that is considered a vote AGAINST the remit question.**

The study guides that follow are offered to help pastoral charges and presbyteries decide how to vote. Voting forms have been mailed to all pastoral charges and presbyteries.

### Important voting deadlines

- Remits 1, 2, 3, and 4: votes must be received by **30 June 2017**
- Remits 5, 7, 8: votes must be received by **17 February 2017**
- Remit 6: votes must be received by **28 February 2018**
